Auto Pedestrian Collision

Mid-Block Crosswalk on NE 24th Street between 161st Ave and 162nd Ave NE

On December 6, 2011, at approximately 6:50 p.m., a 16 year old student walking in the crosswalk was struck by a vehicle. The pedestrian sustained injuries, and Bellevue Police Department and Medics responded. Please contact a SFCC Board member if you have any information regarding this accident.

SFCC had previously expressed concerns about safety at the mid-block crosswalk to the Bellevue City Council. On December 12, 2011, SFCC addressed the Bellevue City Council regarding the accident and reiterated concerns about safety. The initial response from Bellevue staff opined that sign placement and lighting at the crosswalk are adequate and meet design standards. SFCC will continue to pursue this matter with the City in an effort to improve safety at the crosswalk on NE 24th Street.

Block Watch Report

2011 showed our Block Watch awareness improving with the addition of new "Block Representatives" for blocks that had none, installation of block watch signs on our street entrances, and increased deterrents such as yard maintenance and increased lighting around houses. Although the city's crime statistics website has been down lately, we have seen less incidents in 2011 than we had in 2010. Remember, "It is OK to dial 9-1-1", - Bellevue Police Detective Richard Chinn encourages SFCC residents to call 911 if we notice any suspicious activity in our neighborhood. If you notice any activity that does not seem right, call 911 and an officer will investigate.

2012 Annual Dues

Article III of the Sherwood Forest Community Club By-Laws provides for assessment of annual membership dues. The dues fund expenses associated with SFCC operations including State non-profit corporate filing fees, P.O. Box rental, printing, postage, office supplies, and community projects. Sherwood Forest Signs

The Sherwood Forest signs located at the corners of NE 24th Street/160th Avenue NE and NE 30th Street/164th Avenue NE were carved many years ago by internationally renowned local wood carver Dudley Carter (1891-1991). Recognizing the historical significance of

the signs, the City of Bellevue and contractors protectively removed, stored, and reinstalled the signs during roadway/sidewalk projects on NE 24th Street and NE 30th Street.

The signs appear to be in need of repair and restoration. SFCC will be researching options to address the current condition of the signs.

Sherwood Forest Community Club Bylaws, ARTICLE 1, Section 1: "NAME: Sherwood Forest Community Club – More particularly described as that residential community within the district generally bounded by N.E. 24th Street on the south, 164th Avenue N.E. on the east, Bellevue-Redmond Road on the north, and 156th Avenue N.E. on the west." Included within these boundaries are the neighborhoods of Sherwood Forest, Sherwood Gardens, Peachtree, and Belmore.
