Block Watch Develop and implement, block-by-block, the City of Bellevue Block Watch program to promote residential awareness, safety, and security.

Communications Develop and maintain an electronic communication system. Help with publication of Quarterly SFCC newsletters and any other community materials.

Emergency Preparedness Develop and implement a block-by-block preparedness program to address impacts from severe storms, earthquakes, and other disaster.

Land Use Monitor Bellevue and Redmond land use development proposals affecting the Sherwood Forest neighborhood. Have contact with City of Bellevue officials on Land Use. Be involved with City of Bellevue Land Use events, send summary of event back to SFCC Board.

Neighborhood Enhancement Monitor the Bellevue Neighborhood Enhancement program, including announcements and proposals for NE Bellevue from City of Bellevue. Solicit feedback from residents and other means such as social media, email etc, on enhancements to the neighborhood.

Traffic & Transportation Committee Monitor Bellevue and Redmond transportation plans, proposals, and projects with the potential to impact the SF Neighborhood.

### **Bellevue Technology Center**

On July 26, 2016 City of Bellevue hosted a meeting to evaluate the application for a rezone of Bellevue Technology Center. The applicant intention is to remove the existing PUD currently protecting the area for further development. Removal of the PUD agreement would allow for additional office and/or housing development on the Bellevue Technology Center Site. Since 1972 the PUD has ensured that the parcel of land was not subdivided into residential housing but was developed as one unit with a plan to preserve the open space and the trees that surround the property while allowing for minimal development at the site. Previous to the meeting, residents of Sherwood Forest and adjacent neighborhoods partnered together and collected about 600 signatures supporting the PUD remains in place. During the meeting the attendants had the opportunity to present their comments to City of Bellevue and

It is presumed at this time the applicant is working on traffic analysis and modeling. Once this information is presented to City of Bellevue, a second meeting will be scheduled. According to the city planner, this is expected to happen sometime before the end of the year. All parties of record will receive notifications and the information will be also published on City of Bellevue weekly permit bulletin. # **Emergency Preparedness - Basic Measures**

Some basic protective actions are similar across many different hazards

Physical safety is a concern for all hazards and may involve sheltering or evacuating

Make a Plan: Determine evacuation routes, designate meeting places outside your home and your neighborhood. Assemble an Emergency Kit. Learn Skills: Take a first aids class, learn how to turn off your utilities, learn how to use a fire extinguisher.

Practice Drills.

Develop a Family Reunion Plan

**Emergency Supply List:** 

- Water, one gallon per person per at least 3 days for drinking and sanitation
- Food, at least 3 days supply of non perishable food
- Battery-powered or hand crank radio & extra batteries
- Flashlight and extra batteries
- First aid kit
- Whistle to signal for help
- Dust mask to help filter air
- Plastic sheeting and duct tape to shelter in place
- Wrench or pliers to turn off utilities
- Can opener
- Local maps

Additional suggestions:

- Prescription medications and glasses
- Infant formula and diapers
- Pet food and extra water
- Important family documents: in a waterproof container
- Cash or traveler's checks
- Sleeping bag or warm blanket for each person
- Complete change of clothing
- Fire Extinguisher
- Matches in a waterproof container
