Message from the President

Greetings Neighbors,

My name is Lee Sargent and I am privileged to be your current SFCC president, inspired by our past presidents, most recently Emmanuel Solis. I have lived in Sherwood Forest for 41 years and I worked for Unigard Insurance (now in BTC) for 35 years. I have seen many changes and watched the SFCC fight some battles, which have resulted in victories and helped residents gain benefits.

We, as a club, have no legal authority, except through the power of presence, working together and consolidating our presence at meetings. This has worked and the City of Bellevue, responds - just ask Emmanuel Solis or, before him, Regi John. The most recent accomplishment was led by Emmanuel and Janet and prevented the BTC group from allowing more frequent City Master Plan reviews. This helped the City reduce expenses, focus on current planning direction, and cut down the number of repeated requests by developers. What did this cost the Forest? It cost planning time and time spent speaking to the City Council members

earnestly. This was aided by other Forest residents just showing up at a few meetings with them.

Thank you Emmanuel, Janet, Patrick, and everyone else, for being such inspirational examples to us all! It didn't cost a lot of money. It did require time and presence. It worked!

We (the SFCC board) strive to represent you in many ways. We want to represent you fairly in discussions with the City of Bellevue, to make you aware of issues that are occurring, in planning for future needs, in methods of allowing us to help each other and to know what you want us to do. Help us, please.

There are a lot of us who share this neighborhood we call Sherwood Forest and, because of that, we need to get to know your view of our neighborhood. We want to hear from you of what you see that needs improving, what is working well - and your support, in large and small ways, will make this work.

♦ Block Watch

Develop and implement, block-by-block, the City of Bellevue Block Watch program to promote residential awareness, safety and security.

♦ Communication

Develop and maintain an electronic communication system. Help with publication of SFCC Newsletter and any other communication material.

Emergency Preparedness

Develop and implement a block-by block preparedness program to address impacts from severe storms, earthquakes, and other disasters.

Land Use

Monitor Bellevue and Redmond land use development proposals affecting the Sherwood Forest neighborhood. Have contact with City of Bellevue officials of Land Use.

♦ Neighborhood Enhancement

Monitor the Bellevue Neighborhood Enhancement program, including announcements and proposals for northeast Bellevue. Solicit feedback from residents.

♦ Traffic & Transportation

Monitor and report to the SFCC Board of Directors regarding traffic flow patterns and speeds throughout SFCC neighborhood. Monitor Bellevue and Redmond transportation plans, proposals and projects with the potential to impact the Sherwood Forest Neighborhood.
