

SHERWOOD FOREST COMMUNITY CLUB Executive Board Meeting Minutes

DATE: September 27, 2020

TIME: 7:00 p.m. LOCATION: Via Zoom

- 1. Call to Order: The August SFCC board meeting was called to order at 7:00 p.m. Attendees: Emmanuel Solis, Janet Castaneda, Lee Sargent, John Haro, Patrick Tousignant, Kurt Howeler and Anne Drebin.
- 2. **Motion to approve Minutes from previous meeting:** Minutes for the Board Meeting held on 8/20/20 were discussed and approved at this meeting. Motion to approve made by Emmanuel and seconded by Patrick. No discussion and approved by all.
- 3. **Treasurer's Report:** The report as of 8/31/20 was presented by John and reviewed during the meeting. Checks pending to post: John has deposited all the checks received last month. There are a few more that have trickled in and those will be reflected on next months' report. Patrick motioned that John be approved to buy some paint (stain) for the SFCC signs. Kurt seconded and it was approved by all.
 - a. Budget overview: Checking \$696.51 | Savings \$3,820.12 | Total: \$4,516.63.
 - b. Dues update: \$410.00 in dues received, along with \$135 in donations. Emmanuel & Janet renewed the website domain. They are going to make that a donation to SFCC instead of asking for reimbursement.
 - c. Payments: N/A.
 - d. Reimbursements: Patrick will submit his bill for the monthly Zoom fee (\$16.48).
 - e. Monthly reports: No updates
 - f. Motion to approve Treasurer's Report: Patrick motioned to approve, Kurt seconded. Moved and approved by all.
- 4. **Membership Drive / Neighborhood Involvement:** Lee was encouraged that there have been some people participating in the Zoom meetings. He'd like to see that number grow. Lee is going to create a method to update the master database with current contact info for the residents, incorporating the info John has from the treasurer's report. Lee feels the info from the treasurer's report should stay as-is since it has historical data. Lee will get contact lists out to the block reps and they can work on making any revisions when they pass out the newsletter for the annual meeting. The annual meeting will be held via Zoom on 10/22. The newsletter for the annual meeting needs to be put together and distributed soon. The target is having the content ready by 10/3, printed the week of 10/4 and ready for delivery the weekend of 10/10. The newsletter should be short and simple, just letting people know about the annual meeting.

Emmanuel will put last years' newsletter and annual meeting presentation on One Drive so everyone can update their sections. Lee will get in touch with the block reps and see if he can count on them to attend the annual meeting and help drum up more interest from the residents. There will be a couple open board positions (Vice President and possibly Secretary). We need to try to find folks who will volunteer to fill these roles. Janet was going to check with Sam Osheroff to see if he might be interested. Anne will check with Nate Kessler. Emmanuel found that there's a way to do voting on Zoom. He sent the link to Patrick and Patrick will see about getting that set up for the annual meeting. Kurt is in his 3rd year as a Trustee and asked if he was eligible to be reelected. The wording in the bylaws is not real clear and should be reviewed. Emmanuel suggested we perhaps look at the bylaws to see if any sections should be updated.

- 5. Emergency Preparedness (EP): There have been a couple good meetings, but it's tough to get a lot of people involved. Thanks again Janet for getting Joseph Joy lined up to help out. Rebecca Chatfield from the City joined the last EP meeting and was very helpful. Lee has posted tips on Nextdoor in the hopes that will spark some interest. Lee would like to see 4 or 5 folks step up and be there on a regular basis to help get things really rolling. We still need the block reps to get updated contact info and a list of who/how to communicate during emergencies. Lee would like to see the website revised so that there's a menu item at the top for EP (Emmanuel has done this). Things like the meeting presentations, helpful links, etc. can be placed under this tab. In August we talked about putting together an EP newsletter. We should probably look at this again after the annual meeting.

- Research / determine if SFCC we should provide matching funds to get everyone water containers.

- Appoint one person to be the SFCC SPOC to interface with Police, Fire, etc.
 Owner: TBD ongoing action item
- See if the block reps would be willing to do welfare checks on the folks on their blocks and report in to the SPOC.
 Owner: TBD – will include as an agenda item for the block rep meetings.
- Make a directory of tools and skills people in SF have available.
 Owner: TBD ongoing action item
- 6. **General Q&A (Open to the Public):** Lee likes the idea of having an open Q&A session at the start of the Monthly Meetings so that people can come by to hear what's going on with the Board and Community. It will also be a forum for residents to ask questions, or inform the Board about what's happening in the neighborhood. Several people joined the July meeting. Action Item:

Put a notice on the SFCC website each month and NextDoor notifying residents of upcoming board meeting and inviting them to join the Zoom call at 6:30 if there's anything they want to discuss Owner: Emmanuel / Lee – ongoing for every meeting.

7. **Historical SF Documents:** John tracked down a contact at the Eastside Heritage Center. John would like to go thru the documents Patrick scanned and find a few interesting items to add to the Eastside Heritage site. Kurt felt they may already have some SF records. John will follow-up and see what might exist. Patrick will upload the scanned files to OneDrive so John can start looking around.

He'd like to see the City do something to make the corner more visually-appealing. The City says they don't have money to

The City is also planning to release a draft of the Environmental Stewardship Plan later this summer. As of the July meeting, Lee still hasn't seen the survey results.
